NATIONAL CONSTITUTION

Article 111 Membership

Section 5. Yearly dues assessed by the National Organization will based on the first Handicap Service Provider calculation of the year. Dues must be accompanied by a roster of the members included in the dues. Handicap Service Provider Computing Corporation shall be the official handicap agency of this organization.

UPDATED TO READ:

Section 5. Yearly dues assessed by the National Organization will be based upon the first billing by our Handicap Service Provider, Player Counts by Club on January 1st of the current year. Dues must be accompanied by a roster of the active members, including the network members number from the Handicap Service Provider and the per capita for each active member.

All Chapters are required to clean up their membership rosters by December 20th of the current year for the national treasurer to properly bill each chapter correctly the following year.

5. A Schedule of billing & Payment due dates:

Billing: All Chapters will be invoiced January 1st of the current year for active members as of January (of the current year).

Payment: All chapter payments are due in full by February 1st on current invoice from January 1st of the current year.

Billing: June 1st of the current year. All chapters will be invoiced for all active members count by Handicap Service Provider of New and re-activated members added after January 1st of the current year.

Payment: **July 1**st of the current year. Payment is due in full of current invoice from **June 1**st of the current year.

Billing: October 1st of the current year. All chapters will be invoiced for active member count by Handicap Service Provider of new and reactivated members added after 1st of July of the current year.

Payment: November 1st of the current year. Payment is due in full of current invoice from October 1st of the current year.

All annual (Dues/Per Capita) start on **January 1st** thru December 31st at \$11.00 per member.

Section 5. B A Chapter Delinquent in Dues:

If a chapter does not pay their dues by the scheduled dates listed on Section 5.A., the National PAGA Tournament Director will deactivate all delinquent chapter member handicaps in our Handicap Service Provider.

Section 5.C Reactivation Fee:

A \$50.00 reactivation fee will be assessed to a delinquent chapter to reactivate its membership. The reactivation fee will be paid in advance before the chapter is reactivated.

Section 6.

A chapter delinquent in dues or other indebtedness from the previous calendar year shall not be eligible to participate in National Meeting and/or National Tournament. Said delinquent chapter may be seated at the National Meetings and allowed to participate in the National Tournament upon receipt of delinquent dues prior to January 15.

Section 6. A chapter delinquent dues or other indebtedness from the current year shall not be eligible to participate in any National Meeting and/or National Event. Said delinquent chapter may be seated at the National Meetings and allowed to participate in the National Event upon receipt of delinquent dues prior to any National Event.

Annual Dues/Per Capita starts on January 1st thru December 31st. Per capita Membership Dues is \$11.00 per year.
