501 (c) (3) REPORT

The National Pan American Junior Golf Association Inc. (NPAJGA Inc.) was incorporated in the State of Texas on March 23, 1998.

September 25, 1998 qualified for State Franchise Tax exemption. Qualified for exemption from State and Local Taxes. Required to file , every four (4) years, PERIODIC REPORT-NON PROFIT CORPORATION. All of the PAGA chapters are required to file this report.

It was recognized as a 501 (c) (3) Private Foundation on September 11, 1998 and recognized as a "public charity" on October 9, 2003.

PURPOSE

The primary goal of this entity will be the creation of SHOLARSHIPS to benefit all minority and primarily Hispanic youths wishing to attain financial assistance to an education . All youths will be eligible to apply for financial assistance from the NPAJGA Inc regardless of race or creed.

To promote golf in our communities, by sponsoring golf clinics and tournaments. To invest in our communities and young citizens by providing educational assistance to as many youths as possible wishing to further their education.

ARTICLES OF INCORPORATION

In order to maintain our Non-Profit 501(C-3) status we are required, by law, to comply with the strict requirements as set out by the Treasury Department (IRS). A strict and complete accountability of the use of our TAX ID Number is as follows:

1. The Chapter requesting such use must do so by requesting in writing the use of our Non-Profit Tax ID Number.
2. The purpose of the use of the Tax ID Number.
3. The name and date of the function utilizing the Tax ID Number.
4. The purpose of the function.
5. The name and amounts being solicited from the participating entity.
6. The exact amount and or product being donated by the entity.
7. A Financial Report is required to be submitted within 30 days after the Function accounting for the money raised and most importantly the distribution of that money. The distribution of the money must include the name and amount donated to the recipients. The balance must be turned in to the Junior Golf Association, Inc.

The use of the Tax ID Number (W-9) shall be valid solely for that function being conducted by the requesting PAGA Chapter. Any other use of the Tax ID Number is a violation of IRS Non-Profit Laws, Rules and Regulations.
