

2021 NATIONAL PAGA WINTER MEETING DELEGATES MEETING – APRIL 23, 2021 NATIONAL SECRETARYS REPORT

Dear Members,

I think it is fair to say that over the past year, PAGA has faced both challenges and life changes with Covid-19. Still to this date we are still taking on those challenges with it looking closer and closer to being in the rear-view mirror. It's great to able to have a PAGA meeting and golf tournament feels like an eternity that we have gathered.

Since our last meeting in October of 2019. I have had the opportunity to visit several chapters such as San Angelo, New Braunfels, San Marcos, Brazoria County, El Paso, Dallas and Fort Worth. I feel it is my duty as, National Secretary, to be visible with chapters and to show NPAGA Board leadership.

As National Secretary my duties are to report minutes unfortunately I was unable to do so after a malfunction with the video recorder in San Marcos at the 3rd Delegates Meeting and Workshop. I do apologize and will ensure the video camera will be recording during all delegates meetings.

Below is a quick summary of my work in the past 12 months.

- Added a delegate's tab on startershack via George Riley (to be only used by the present delegate of each chapter) will make it easier to present items to only the delegates when needed by the NPAGA Board.
- Continuing former NPAGA Secretary Charlene Bourgeois idea of recognizing veterans on the NPAGA website.

- Created a chapter directory with each chapter's current board members on the NPAGA website.
- Organized Zoom Meetings for the National Officers
- Emphasized on having a correct email address on startershack without a correct email we cannot pass on information to members.
- Publishing a monthly PAGA schedule to showcase some of the chapter's outings and invitationals. Hopefully helping to get more participation in supporting of other chapters events.
- Currently investigating if the NPAGA name and logo are registered/trademarked. If not, we would need to do this asap to secure it with a patent.
- Continuing to promote NPAGA on Facebook with its free advertising tools.
- During January 5-12, 2021, I contacted each chapter to conduct business and record each chapter's decision on items that needed votes. It was a unanimous decision with 34 out of 35 chapters approving of the changes. These items were voted on:
 - 1. Accept the golf association out of Presidio, Texas to become our next chapter (34/35)
 - 2. Agree to allow only 6 tournament scores to be able to participate in the National Tournament in Brownsville, Texas for 2021 only. North chapters 4 scores South chapters 6 scores (34/35)
 - 3. Due to COVID19, agree for chapters to stand by their designated area during the parade of colors and only stand when acknowledging the chapter. (34/35)

Thanks to the New Braunfels President John Alanis and the whole PAGA of New Braunfels chapter for hosting the 2021 NPAGA Winter Meeting.



The National Pan-American Junior Golf Association is a 501 c (3) Non-profit organization. In partnership with the National Pan American Golf Association our primary purpose is to provide opportunities that will foster sports competition between amateur youth athletes. The NPAJGA also provides financial assistance to NPAGA Chapters interested in organizing junior golf tournament and clinics in the perspective community. Financial assistance for these activities comes through donations from local NPAGA chapters and their members, private individuals and other generous corporations.

ARTICLES OF INCORPORATION


