Subject: National PAGA Tournament

Please review the following observations and suggestions that came to light during and after the National PAGA tournament was held in El Paso this July, 2022.

- 1. The Board talked about changing the format of the National Tournament and eliminating some of the functions the host chapter offers at the National tournament. The problem with not going forward with this idea is that the costs associated with this tournament are increasing. Because of the increasing costs and reduced participation, the host chapter will suffer losses or decreased results. To give you some background, in 2008 El Paso had 522 participants, in 2014 El Paso had 419 participants and for 2022 El Paso had 244 participants, a decrease of 53% from 2008 and 42% decrease from 2014. Therefore, the El Paso chapter basically broke even. In the past the El Paso chapter has generated monies from the national tournament to increase our scholarship program above what the chapter was able to generate during the year. Scholarships for 2022 from the El Paso chapter will have to be adjusted.
- 2. The National tournament in El Paso had skins and wagering this year. As a result, El Paso tournament team had to calculated the winning and forward the winners checks to their chapters. However, several of the chapters used their chapter checks with addresses that were no longer valid. Therefore, El Paso had to wait for the checks to be returned before they could be forwarded to the correct address. In the future, the host chapter should require an address for each chapter as to where to send checks.

Hopefully you will consider these suggestions as a way to improve the success of the National tournament.







Subject: Proposed changes to the Constitution

Delegates,

Attached are two proposed changes to Article V, Meeting Procedures, of the National Constitution. The first proposal is an addition to SECTION 2. Section 2 requires a minimum of 3 National Business Meetings per year. As we have learned from the pandemic there will be events beyond our control that prevent the in-person assembly of the delegation. The proposed addition will allow the usage for Video Conferencing services to duffill our national meeting requirements. Note the use of video conferencing does not replace the assembly of the delegation when conditions permit.

The second proposal updates SECTION 3. Section 3 allows for the National President to call a special meeting by notifying the delegates 30 days prior to the meeting. The proposed changes include the use of email in addition to Tst class mail for the notification process. Also, for these special meetings would be conducted using video conferencing services.

SECTION 3,

The National President may call a special meeting by notifying the National Delegates by first-class mail at least thirty (30) days prior to conducting said meeting. Delegates shall their failure to respond shall be taken as affirmative votes and the meeting shall take information, name a time and place of said meeting. If the delegates fall to respond, najority of said delegates favor a meeting, the President shall, upon receiving said espond within fifteen (15) days of the posting of said mail by the President.

Video conferencing for delegate meetings

Benefits

- Business continuity. Board and delegates can still meet and conduct business when unforeseen events cause the cancelation of normally scheduled Winter Meeting, National Tournament and Conference, and National 3rd Delegate's meeting.
- Can be used for emergency board / delegates meetings.
- Can improve attendance and representation of chapters who are unable to attend National delegates meeting. This is especially true for distant chapters who do not also make the Winter or 3rd meeting.
- Allow attendance to scheduled board minutes. Attendee's do not have to be participants
 but can observe board meetings. The board would reserve the right to halt the video
 conference when the discussion focuses on protecting the rights of individuals.

What video conferencing is not meant for:

- The replacement of any National delegates meeting.
- Video conferencing would only be used in emergencies or when circumstances beyond our control, normally referred to acts of god.

SAPAGA JR Golf Program NPAGA Pilot / Template



Purpose:

The purpose of this is to serve the community through outreach to San Antonio Youth and provide not only introductory instruction but a golf league that is affordable to them and encouraging golf play for the rest of their lives.

Means:

Membership – A \$30 membership fee allows their children to become members of the San Antonio Pan American Golf Association. (A portion of that \$20 will be used for the member to join the youth on course program) If the child is already a member an administrative fee of \$10 will be charged.

Through the membership the club will offer:

- Bi-Monthly golf clinics to include 1 hour of instruction.
- competitive play on Saturdays (9 hole tournaments starting at 1:00 at various local golf courses)
- quarterly golf playing opportunities with other chapters of the PAGA such as, Austin, New Braunfels, San Marcos, Seguin, Austin, Lockhart, Victoria, Corpus Christi, North Hays, Waco, Irving, Fort Worth, Dallas, Odessa, and any other PAGA chapter that wishes to participate

Volunteers:

As the organization grows it will be crucial to recruit as many volunteers to help facilitate and run organizational clinics and tournaments.

Tournament fee: \$0, all tournaments will be run through volunteer help and also request assistance from the National PAGA Ir golf organization to provide:

- Medals and trophies
- Lunch

Structure:

The Youth Golf league will consist of the following groupings:

- 4-5 boys and girls combined (3 holes 50 yard tees)
- 6-7 boys and girls combined (4 holes 75 yard tees)
- 8-9 boys and girls combined (6 Holes 100 yard tees)
- 10-11 boys (9 holes 150 yard tees)
- 10-11 girls (9 holes 150 yard tees)
- 12-13 boys (9 holes from regular red tees)
- 12-13 girls (9 holes from regular red tees)
- 14-15 boys JV (18 holes white tees (players shooting above 90))
- 14-15 girls JV (18 holes -white tees (players shooting above 90))
- 16-18 boys Varsity (18 holes -blue tees players shooting below 90))
- 16-18 girls Varsity (18 holes blue teesplayers shooting below 90)

Tournament structure points system

The purpose of the point system is to encourage and recognize the players that are committed to the league.

- All local participants will earn 5 points for playing weather they place or not
- 1st place earns 15 points, second earns 10 points and 3rd place earns 5 points
- In a quarterly out of town tournament all players earn 10 points for participation and the normal points for 1st, 2nd and 3rd place

Organizational Structure:

A JR Golf committee Chairman will be selected to run a committee that will oversee the program and recruit volunteers to assist in operational function to include:

- Scorekeeper
- Host
- Player Parent and Club communication
- Working with fellow Chapter JR committees to coordinate out of town rotation and tournaments (Out of town registration will have windows that will be 3 weeks before the tournament.
